COURSE OBJECTIVE

The Department of Transportation recently amended certain provisions of its drug and alcohol testing procedures (49 CFR Part 40). This training course is being offered to provide transit properties with specific details of the new amendment revisions and how these changes will affect them.

Participants will be introduced to a new FDOT model policy template that will incorporate the new amendment revisions. This course will also offer participants an opportunity to discuss best practices that meet or exceed regulatory compliance in all areas of drug and alcohol testing programs.

Upon completion, each attendee will receive a certificate of completion from the Florida Rural Transit Assistance Program.
